Domestic Violence, Defined

Domestic violence is a pattern of abusive behavior within a relationship that is used by one partner to gain or maintain power and control over an another current/former partner. It can happen in relationships where couples are married, living together, dating or have a child together. Domestic violence can be physical, sexual, emotional, financial actions or threats of actions that influence another person. This includes behaviors that intimidate, manipulate, humiliate, isolate, frighten, terrorize, coerce, threaten, blame, hurt, injure, or wound someone.

Sexual Violence, Defined

Sexual violence involves forced, or unwanted or attempts to force any sexual contact when someone does not or cannot give consent. Sexual violence is a range of behaviors from sexual harassment to a completed non-consensual sex act. Survivors of sexual assault may know the perpetrator such as an acquaintance, relative, current or former dating partner/spouse, or the perpetrator may be unknown. When someone rapes/assaults/harasses, their motivation stems from their need for

Dating Violence, Defined

Dating violence is violence committed by a person who is or has been in a social relationship of a romantic or intimate nature with the victim/survivor. The existence of such a relationship is determined by the length of the relationship, the type of relationship, and the frequency of interaction between the persons involved in the relationship.

Stalking, Defined

Stalking is engaging in a course of conduct directed at a specific person that would cause a reasonable person to fear for their safety or the safety of others or to suffer substantial emotional distress.

Sex Trafficking, Defined

Sex trafficking occurs when someone uses force, fraud, or coercion to cause a commercial sex act with an adult or causes a minor to commit a commercial sex act. A commercial sex act includes prostitution, pornography and sexual performance done in exchange for any item of value, such as money, drugs, shelter, food or clothes.
